Raising a Complaint in the Interest of Students Career with Hon'ble Chief Minister Punjab S, Bhagwant Singh Maan against Vice Chancellor (Officiating), Registrar (Officiating) and Dean Academics (Officiating) and Managing Committee of DAV University, Village Sarmastpur Pathankot Road, Jalandhar for cheating and fraud with hundreds of students and parents by criminal conspiracy, forgery by doing fake commitments. The Punjab government should start a mega drive to improve the quality of agricultural education in the State Universities which are below the benchmark and it should be started from DAV University, Pathankot Road, Jalandhar. Kindly order surprise inspection and assessment of DAV University, Pathankot Road Jalandhar by the competent authority. And an order to lodge FIR against VC, Registrar and Dean Academics of DAV University Jalandhar which is working against the rules and providing substandard education to the students. DAV University is working without NAAC (National Assessment and Accreditation Council) & ICAR (Indian Council of Agricultural Research) accreditation and authorisation were playing with the future of the young and this should not be tolerated in the Governance of Hon'ble CM Bhagwant Mann. DAV University Cannot run Agricultural courses curriculum because they do not have accreditation from ICAR (Indian Council of Agricultural Research) since the beginning of the DAV University (2013) which is mandatory to run the degree course. DAV University Jalandhar does not have sufficient land & infrastructure which is required to establish the Agricultural Science Degree Course & Research. Infact Vice Chancellor, Registrar, Dean and Managing Committee is misleading the students and parents for taking admission in the DAV University as they do not have NAAC (National Assessment and Accreditation Council) & ICAR Accreditation since commencement of university in 2013. The Vice Chancellor, Registrar and Management Committee do not inform the parents and students about the accreditation status of the DAV University before giving admission to the students. The Investigating Officer should seize the Passport of the Vice Chancellor, Registrar and Dean as they have committed fraud and cheating with hundreds of students and parents. Moreover some non-teaching staff members do not have a valid degree / qualification related to their jobs. Since regional language is mandatory so please check whether all the faculty and staff members of DAV University have studied Punjabi upto matric level or not because DAV University is regularised under the Punjab Vidhan Sabha Act. Infact Investigating Officer should take statements of the students and parents who are pursuing and have completed bachelor's degree courses in Agriculture from DAV

University. Approx 605 students have obtained Agricultural degrees from DAV University in 2015-2021. The probe of the above matter is to be investigated under the supervision of Senior Officials. The Investigating Officer should collect all the digital evidence records, incriminating documents & other documents during the raid which clearly depict the fraud with students and parents is being done. DAV University is causing wrongful loss to the future career of the students. DAV University does not have facilities for agricultural research. There are no job opportunities after doing Bachelors degree in Agriculture from a Non-ICAR University. Students cannot pursue a Master Degree Course in Agriculture, if the student is bachelor from Non ICAR University. Pursuing graduation in agriculture course through non ICAR University for students is worthless. Students are not aware that if they are doing BSc in Agriculture from a Private University which has no accreditation from ICAR cannot appear for the JRF Exam (Junior Research Fellow). Hundreds of students of DAV University told that they were cheated by the DAV University as their course was not approved by the ICAR. Without approval the students in undergraduate courses in agriculture are not eligible to get admission for post graduation courses. Most of the teachers are being recruited on contractual basis and after some time they leave the University for their better future at some other place. The data can be collected from the HOD of the various departments. They are looking for their uncertain future. As per guidelines of ICAR only those students will be allowed admission in the post graduation courses whose Universities have received accreditation from ICAR. DAV University hasn't received the accreditation of NAAC & ICAR since its commencement of year 2013. For the last nine years DAV University has been under process for getting accreditation from ICAR & NAAC. Students will start protesting against VC, Registrar, Dean and DAV Management. The above information has been collected by me under RTI. But PIO failed to furnish the information of my RTI applications.

You are requested to kindly direct the officials to take this complaint seriously and take immediate and strong action for the future of students with immediate effect.
